

## **Standards for a Learning Supports Component**

The timing is right for adopting a unified set of standards for student and learning supports. As states and districts move in new directions for enhancing equity of opportunity:

- Development of standards for learning supports is essential to the success of initiatives such as the ones focused on enhancing standards for curriculum and teaching.
- Development of such standards is essential to guide development of a unified and comprehensive system of learning supports to address barriers to learning and teaching and re-engage disconnected students.
- Development of such a system is essential to educating the whole child and to enhancing equity of opportunity for all children and youth to succeed at school and beyond.

**The Prototype:** The prototype standards for a learning supports component was developed with input from a superintendents, principals, teachers, support staff, community agency staff, professors, and more.

The work is intended to ensure that the nature and scope of a unified and comprehensive *system* of learning supports is understood and to guide adoption of such a system. As the proposed standards and indicators underscore, a learning supports component coalesces and systematizes what is common in all student and learning supports and provides a base upon which the needs of specific student subgroup, the contributions of various professional specialties and specific programs, and the unique considerations of localities can be built.
