

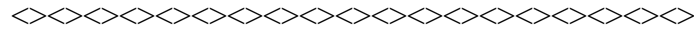

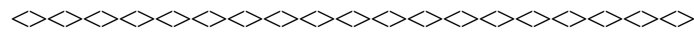

****EMERGING ISSUE****

Renewed Debate Over Random Searches of Students at Schools

The ACLU has filed a suit accusing the Los Angeles Unified School District of violating students' constitutional rights by subjecting them to unreasonable search.

One side on this issue states that the searches may be an inconvenience, but the benefits in terms of keeping weapons out of schools outweighs any costs in terms of student discomfort and resources expended.

The other side argues the process makes kids feel like criminals and school feel like prisons and that the funds could be better used for more programs, teachers, and counselors.

In response to last month's (re)emerging issue on Corporal Punishment, this comment:

"I am a southern transplant having moved from NYC about 6 years ago. In (my county) corporal punishment was eliminated in 1991. However, many of the surrounding counties permit corporal punishment...Furthermore many of the parents I have met believe in it strongly...I was shocked to see corporal punishment still being practiced and condoned by many parents."

In response to May's emerging issue on Small Schools, this comment:

"There seems to be no argument over the key element in a successful school...the quality of the staff...getting and keeping good people should remain the top priority in education reform..."

In response to a Net Exchange question about resource mapping, this comment:

"I have worked in a school-based health center located in an alternative high school setting for about 4 years now. I have repeatedly attempted to get our setting engaged in resource mapping but continue to get a negative response. We are a very diverse multidisciplinary setting but it seems that there is more coexisting than collaborating. Can you share some advice on how to "sell" the idea to educators? I think I need some help identifying what might motivate our principal and others to buy-in to the process, I feel as if I could use some help speaking the language"

This is one of a set of 12 brief documents covering overview/vision/research base; policy direction & commitment; building and sustaining local capacity; new professional roles and functions. If you are on our mailing list, you should soon receive our Spring, 2001, quarterly hardcopy newsletter. The lead article is "Opening the Classroom Door" -- covering how to prevent problems and intervene early before students need referrals for out of classroom interventions. An Ideas to Practice article discusses working with intrinsic motivation.

We are currently working with the Safe Schools/Healthy Students Action Center consultant brokers to draft a resource on sustaining programs. It is tentatively titled: "A Guidebook and Toolkit on Sustaining School-Community Partnerships to Enhance Outcomes for Children and Youth".
